



CIVA 10.1: Optimize your CIVA 10

*This new release of the expertise platform for Non Destructive testing simulation includes a lot of **improvements** and **bugs fixing** within the 3 existing modules UT, ET and RT.*

UT Improvements

In order to ease and speed-up the definition of the work piece properties, **the materials database** has been enriched. It includes now about **50 materials** (isotropic, anisotropic or composite).

In **immersion** testing, the **refraction angle** can now be directly defined, the corresponding incidence angle in the coupling medium will be calculated and displayed (only the incidence angle used to be available before). With phased-array transducers, it is now possible to define **focal points in the coupling medium** or at the **interface** between different media. The **ray tracing** has been largely improved with **TRL** and **PA** transducers, especially when using the “beam of rays” options.

In the revolution like work pieces inspected by the side, enlarged **scanning possibilities** are proposed, including an angle of skew.

Post-Processing has also been improved in CIVA 10.1. For instance, it is now possible to **export Cscan** data in text files (all Bscan data included in the Cscan will be exported).

A summary of input data of a given CIVA configuration is also now available both in the beam computation and the defect response module provided in a **Data Information** menu.

It is now possible to export parametric files or 2.5D CAD files created in CIVA in **IGES format**. An automatic **3D CAD** file is then generated.

To ease the use of the software, we have also improved the English **labels** in many menus.

ET Improvements

To help new users to get started with the ET module, **a tutorial** is now available as it was already the case for the UT module. This tutorial is available as a pdf document in the DVD as well as on the CIVA club website.

Post-Processing has been largely improved with the possibility **to Export results in text files** (Impedance plane data, Cscan data), a summary of input data of a given configuration provided in a **Data Information** menu, an easier storage and access to **calibration coefficients**. The **impedance plane** curves are now given in an **equal axis** way.

As for the UT, some English **labels** have also been clarified in the menus.

Like in UT, the **export of 3D CAD** file in IGES format is also available in the ET module.

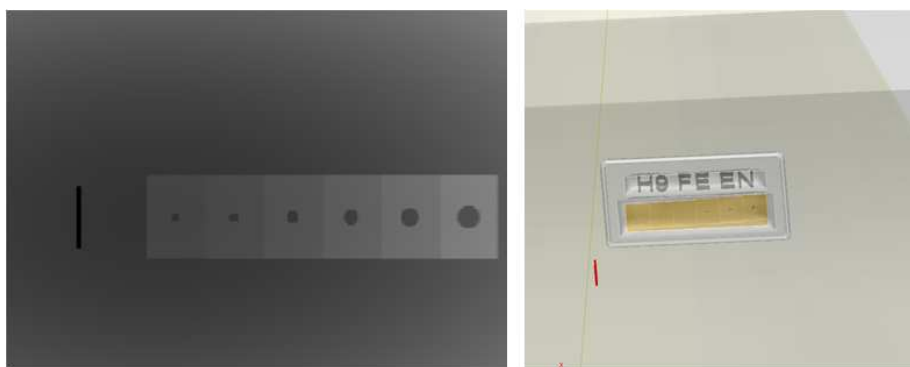
RT Improvements

To help new users to get started with the RT module, [a tutorial](#) is now available as it was already the case for the UT module. This tutorial is available as a pdf document in the DVD as well as on the CIVA club website.

The graphical user interface of the RT module version has been [relooked](#) for this version which makes its use more user-friendly.

A summary of [input data](#) of a given configuration is provided in a [Data Information](#) menu.

To obtain simulation results still closer to real acquisition data, a new [IQI](#) option is now available. A large library of the [main standards IQI](#) is included in CIVA.



In order to ease and speed-up the definition of the spectra of the X-Ray source, [the spectrum database](#) has been enriched. The user could load precomputed spectrum obtained with a Monte Carlo simulation for an X-ray tube with a tungsten anode, a target angle of 20° with other filter. The spectrum energies are from [50 kV to 450 kV](#).

The visualization of the [MTF](#) can be displayed as curves or as a tab in which all the values of the MTF will be displayed in function of the spatial frequency.

As for flaw positioning, [the Mouse Interactivity](#) for [source and detector](#) positioning is now available.

It is now possible to export parametric files or 2.5D CAD files created in CIVA in [IGES format](#). An automatic [3D CAD](#) is then generated.

Bugs fixing

About [100 bugs](#) fixing have been performed within the 3 modules of CIVA.
